SECTION 7: Handling and storage

7.1. Precautions for safe handling

Safe use of the product

: The product must be handled in accordance with good industrial hygiene and safety procedures.

Only experienced and properly instructed persons should handle gases under pressure.

Consider pressure relief device(s) in gas installations.

Ensure the complete gas system was (or is regularily) checked for leaks before use.

Do not smoke while handling product.

Avoid exposure, obtain special instructions before use.

Avoid contact with aluminium.

Keep equipment free from oil and grease.

Use no oil or grease.

Use only properly specified equipment which is suitable for this product, its supply pressure and temperature. Contact your gas supplier if in doubt.

Installation of a cross purge assembly between the cylinder and the regulator is recommended. Passivate all equipment and pipework before introducing gas. Contact supplier for passivation procedure.

Purge system with dry inert gas (e.g. helium or nitrogen) before gas is introduced and when system is placed out of service.

Avoid suck back of water, acid and alkalis.

Do not breathe gas.

Avoid release of product into atmosphere.

Refer to supplier's container handling instructions.

Do not allow backfeed into the container.

Protect cylinders from physical damage; do not drag, roll, slide or drop.
